IRPA 15: Update on Fees and Refunds

Congress Registration and Course Fees

As you can imagine, the need to shift to a primarily on-line conference has had a significant impact on the finances of IRPA 15. While the organisers continue to work extremely hard to deliver the best possible congress we are also conscious that participants expect a lower fee for a virtual event. With this in mind, a revised fee schedule is below. Registration is available until 18 January 2021.

The fee for expert refresher courses is USD 40/course, and beginner courses are free.

Congress Registration and Course Refund Policy

If you have already registered and paid rates higher than those above, you may request a refund for the difference in the rates.

Refunds are also possible if you registered and paid to attend the Gala Dinner or Refresher Courses.
